NOTES:

1. Club glider hire before 11:00 am is at 0p per minute.
2. Club glider hire beyond 3 hours is at 0p per minute – but see note (3).
3. Flights longer than 60 minutes in club gliders must be cleared through the duty pilot.
4. Minimum chargeable time for a cross country aero tow is 30 minutes plus landing fee.
5. Annual Membership fee is pro-rata to whole months (twelfths) in the year of joining. Junior and pre-solo membership fee applies to pilots who were junior and/or pre-solo at the beginning of the membership year (1st March).
6. Country membership applies to members not subject to the BGA capitation fee, including full members of other BGA clubs and members who are tug pilots only.
7. 50% Family discount applies to the lower membership fee of a second and subsequent family member (calculated at 50% of the Full member's rate for Instructors).
8. Friends and family of full members may have a reasonable number of dual flights in any year, paying a 50% daily membership fee (£5) on each occasion plus flying fees at club rates. They should sign a temporary membership form for each three months' membership period.
9. If our standard charges present a problem to people on low income, the Club Committee will consider applications (in confidence) for assistance from club members or potential members.
